

**BACKGROUND CHECK PERMISSION (COMPREHENSIVE)**  
**FOR PROSPECTIVE VEHICLE DRIVER WITH MARKET YOUR CAR INC.**

In connection with my application to render my services and my vehicle for advertising purposes to Market Your Car Inc., of the City of Toronto, Ontario ("The COMPANY"), I hereby agree as follows:

**3. CONSENT TO CONTACT GOVERNMENT AGENCIES**

I further give permission to, and authorize the Company to receive a copy of any information obtained in the file of any federal, provincial, or local court, or governmental agency concerning or relating to me. I further consent to the release of such information to the Company and waive any right under law concerning notification of the request for a release of such information. In the event a law does not provide for the Company to have access to information, I hereby delegate and authorize the Company as my agent for the receipt of information. I understand that the scope of this investigation will be limited as required by applicable law.
